The CEIPI offers several types of training, non-degree courses or diploma courses (masters, university diplomas, short trainings) in initial training or continuing education, in French or in English.

General presentation and specificities

The Center for International Intellectual Property Studies (CEIPI) of the University of Strasbourg is one of the oldest and most renowned intellectual property teaching and research centers in Europe. Its history is closely linked to the development of intellectual property in France and around the world. Through its diversified and constantly evolving training offer, the center, based in Strasbourg, has played a significant role in training generations of intellectual property professionals in Europe and beyond.

In this framework, CEIPI trains specialists in intellectual property law by organizing several training courses. Thus, with over 55 years of experience, high quality teaching methods, a faculty composed of specialized academics and recognized practitioners from national, European and international backgrounds, CEIPI is, today, recognized in all specialized circles as one of the most important academic centers in Europe for teaching and research in intellectual property law. The center also has a Research Department that carries out a mission of fundamental reflection in the field of intellectual property.

Partnerships

The center has concluded agreements with the European Patent Office (EPO) and the World Intellectual Property Organization (WIPO), as well as partnerships with several universities or training centers in the United States, in Europe and Asia.

CEIPI Training offer

Within its French Section, CEIPI offers two university degrees in "Patents" and "Trademarks and Designs" by preparing engineers, scientists, or lawyers for professional examinations to become patent attorneys, as well as six master degrees (LLM) "Intellectual property law and valuation of intangible assets", "Intellectual property law and international business", "Intellectual property law and cultural activities", "Intellectual property law and management", "Industrial property" and a research oriented master degree in "European and international intellectual property law". Since 2019, three new university degrees have been created: "European Union Trade Mark and Community Design Law", "Artificial Intelligence and Intellectual Property" and "IP Business Administration".

Within its International Section, CEIPI is responsible for training future European patent attorneys to become professional representatives before the European Patent Office by preparing these young candidates for the European Qualifying Examination (EQE). This training, decentralized in about thirty European cities, is supplemented by seminars organized in Strasbourg. CEIPI also awards a university diploma in "Patent Litigation in Europe" addressed to patent professionals willing to deepen and update their knowledge in comparative and regional patent law and patent litigation.

Moreover, CEIPI provides training for senior officials from industrial property offices in developing countries. Several short courses are also offered, in initial training or continuing education, in French or English, throughout the year.
